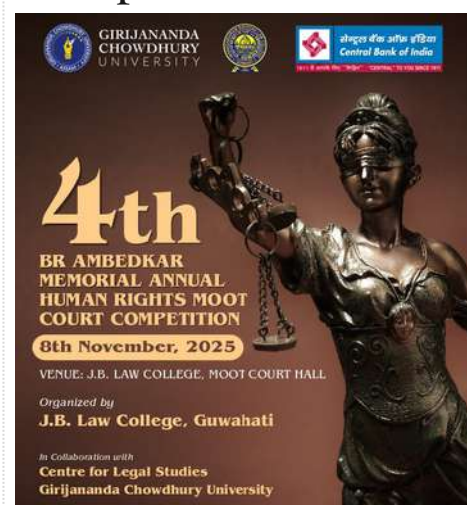

Psychology students gain critical insight into rehabilitation at Vastab Wellness Society

Fifteen undergraduate and postgraduate psychology students from Girijananda Chowdhury University completed a highly beneficial academic field trip to the Vastab Wellness Society in Lachit Nagar, Guwahati, on November 22, 2025. Accompanied by faculty members Dr. Fariza Saidin and Dr. Tejoswita Gogoi, the visit was a structured initiative to fulfill curriculum requirements by providing exposure to mental health assessment, therapeutic environments, and the rehabilitation process for individuals dealing with addiction, substance dependence, psychological distress, and behavioural challenges. Upon their arrival, the group received a warm welcome from the centre's administrative and clinical teams. Mr. Mostak Ali, the Secretary of the society, conducted a thorough orientation on the nature of addiction and the comprehensive framework of rehabilitation employed at Vastab. Students were then taken on a guided tour of the facility, during which staff detailed the holistic daily schedule for clients, which encompasses essential components like individual and group counselling, meditation, physical fitness sessions, skill-building initiatives, and structured relapse prevention programmes. A pivotal part of their academic requirement involved the students performing Mental Status Examinations with selected clients. This crucial, hands-on activity was executed under the strict supervision of the centre's seasoned professionals and their accompanying faculty.

Human Rights Day programme held at Chandraprava Bora Girls' High School

On 10th December 2025, the Centre for Legal Studies, Girijananda Chowdhury University, organized a programme in observance of Human Rights Day at Chandraprava Bora Girls' High School, Azara. Esteemed faculty members of CLS, Mrs. Madhusmita Ronghangpi and Mrs. Pooja Kalita, along with two LL.M. 1st Semester students, Mr. Abinash Narzary and Mr. Mahadi Alam Badshah, under the guidance of Dr. Niju Moni Das, Head, Centre for Legal Studies, GCU, visited the school to educate the students on the human rights enshrined in international and national law. Mrs. Madhusmita Ronghangpi, Assistant Professor of CLS, felicitated Mr. Karuna Nath, Headmaster of the school. She then interacted with the students on the significance of human rights, emphasizing that they are inherent, universal, and inalienable. She explained how the global understanding of human rights took a historic turn after the devastation of the Second World War, leading to the adoption of the Universal Declaration of Human Rights (UDHR) on 10 December 1948. She highlighted various rights, including the right to life, food, sleep, and other essential liberties, and also spoke about the duties of children as responsible human beings. Thereafter, Mr. Abinash Narzary, LL.M. student, explained the importance of the day and the basic child rights, which include the right to survival, ensuring proper nutrition, healthcare, and a safe environment; the right to protection from abuse, exploitation, and neglect; the right to development, encompassing education, play, and a nurturing family environment; and the right to participation, allowing children the freedom to express their views in matters affecting them. He emphasized that children are entitled to special care, protection, and opportunities for growth. E-certificates were also provided to the participating high school students.
